





eComm:

Total consumption (according to SberIndex):

- Consumption in Moscow took a bigger hit during COVID-19 pandemic, but recovered faster.
- In June, with another wave under way, consumer consumption contracted again.





Online sales:

- According to Rosstat, in 2020 online sales accounted for 3,9% of Russian retail sales vs 2% in 2019; thus, online sales doubled during the pandemic year.
- Moscow has the largest share of online sales (9,3% of retail sales), with Novosibirsk on the second place (8% vs 5,3% in 2019). In Saint-Petersburg online sales accounted for 7,3% of total retail sales (vs 4,5% in 2019).
- According to SberIndex research, post-COVID buying habits changed mostly within a younger group of consumers, who were buying online from time to time even before 2020. They tend to stay and buy online even when all the shops were open again. Those buyers, who preferred to buy offline before 2019, returned to traditional shops once they opened (source: https://sberindex.ru/ru/researches/potreblenie-posle-pandemii-onlain-polzovateli-stali-bolshe-tratit-v-internete-konservatory-ostayutsya-oflain). So the overall effect of COVID on eCom was huge (online market grew by 1 trn RUB, of \$130 bn, from April to December of 2020), but not all of it is sustainable.


